BACKGROUND

The Port Commission generally meets on the first Wednesday of each month, starting at 5:00 p.m. for closed session and 5:15 p.m. for regular sessions that have no closed session items on the agenda. These meetings coincide with the City Council meeting dates. Staff is recommending not scheduling a meeting on February 7, 2024 (first Wednesday) but scheduling a meeting on February 21, 2024 (third Wednesday) to spread more time apart from January's meeting and to keep the trend of matching dates with City Council.

Staff is recommending not to schedule a meeting on April 3, 2024 due to scheduling conflicts with the City Council members and to keep the trend of matching dates with the City Council meetings, we will have a meeting scheduled for April 10, 2024.

Staff is recommending not scheduling a meeting on July 3, 2024 due to the July 4th holiday. Therefore, we will have a meeting scheduled for the third Wednesday, July 17, 2024.

Staff is recommending not scheduling a meeting on September 4, 2024 due to the Labor Day holiday. Therefore, we will have a meeting scheduled on the third Wednesday, September 18, 2024.
